

MOTOR VEHICLE/PERSONAL PROPERTY LOAN AGREEMENT

This agreement entered into between AMERICAN HONDA MOTOR CO., INC., a corporation, of 1919 Torrance Blvd., Torrance, California, hereinafter referred to as "Lender", and _____ hereinafter referred to as "Borrower." The following officer, hereinafter referred to as "Rider" will operate said motorcycle as an agent of said Borrower. Rider's Driver's License # _____ Expires _____ State or Country _____ Police Identification Number _____ Law Enforcement Agency _____, Supervisor _____.

In consideration of the loan without charge by Lender to Borrower of motor vehicles and/or accessories hereinafter described and enumerated, (hereinafter referred to as "Vehicles"), it is mutually agreed upon by the parties hereto as follows:

1. The Vehicles loaned hereunder are as follows:

2. Rider agrees that he has examined and inspected the Vehicles above described and states that the same are in first class mechanical and operating condition. Borrower assumes all risks, perils, and danger in operation of said Vehicles.

3. Borrower agrees that he will not permit any other person than the Rider, to use or operate such Vehicles; Rider will not operate such vehicle under the influence of alcohol or any substance which affects the ability to operate or control the Vehicles or not having a valid operator's license to use or operate such Vehicles, and he shall not use or operate said Vehicle or cause or permit same to be used or operated in any manner whatsoever in violation or contravention of any City, County, State or Federal laws, statutes, ordinances or regulation, and that Borrower shall be personally liable for all fines and penalties for traffic law violations.

4. Borrower agrees that in the event of any accident involving the loaned Vehicles, he will within 48 hours following such accident, furnish a Lender a full and complete report thereof, including the extent and amount of damage, and will report said accident to the Department of Motor Vehicles of such state within the time and in the manner prescribed under the provisions of the Vehicle Code of such state.

5. Lender agrees that at all times during the period of the loan of said Vehicles, Lender shall maintain and keep in repair such Vehicles as requested by Borrower, from time to time, at Lender's cost and expense, except for willful misuse of the Vehicle or damage covered under Borrower's insurance policy.

6. Borrower agrees that he will, at his sole cost and expense, maintain primary personal injury and property damage liability insurance coverage for the use and operation of said Vehicles during the time the same are in his possession and until same are returned to the Lender and furnish Lender evidence of such insurance coverage at Lender's request. Borrower does hereby covenant and agree with Lender that he will forever hold harmless and indemnify said Lender from any and all claims, demands, causes of action, court costs, attorney's fees and expenses of any nature relating thereto for personal injury and property damage of any third party or of the Borrower, his heirs, personal representatives, employees or agents or any other party arising or alleged to have arisen from the use, operation, maintenance or ownership of said Vehicle while this agreement is in full force and effect, and to reimburse Lender for any such loss, damage or costs and expenses during said period, except as may be provided under paragraph 5 of this agreement. I acknowledge that I have read this insurance paragraph. _____ (borrower initials)

7. The Vehicles loaned hereunder to Borrower shall be returned to Lender at Lender's place of business or at any place designated by Lender as the point of delivery to Lender's employees or an authorized person of Lender, on or before the date hereinafter designated as the return date, or prior thereto upon demand by Lender. If Borrower damages said Vehicle, such that it is a total loss, or fails to return same for any reason on said return date or on demand, Borrower agrees to pay Lender the dealer's net price therefore. If Vehicle is damaged to an extent less than a total loss then Borrower agrees to either repair Vehicle to the satisfaction of Lender or to pay Lender a sum sufficient to effect the repair of said Vehicle to the same condition as when Vehicle was borrowed. 8. Borrower and Rider acknowledge that they are not an employee or representative of Lender, and would therefore, not be entitled to any benefits of employment, including, but not limited to, for example, worker's compensation or any group or individual medical coverage.

9. Borrower acknowledges that no other written or oral representations different or apart from the foregoing written agreement has been made.

10. Borrower acknowledges that Rider has taken and shown proof of satisfactory completion of a motorcycle safety training course within the last 3 years.

11. Borrower agrees that Rider will not participate in any patrolling or pursuit activities while operating this vehicle.

12. Borrower agrees that Rider will not participate in any competition, or sanctioned riding event (e.g., drill team exhibition) while operating this vehicle or allow the unit to be used in said event.

13. Borrower agrees that he will not add any equipment or accessories to the Vehicles, or otherwise make any modifications to the Vehicles.

14. Rider agrees to inspect vehicle daily and perform all pre-ride inspections prior to operation (e.g., tire pressure, fluids)
